

## Call to Annual Meeting

Dear Members of Michael Servetus Unitarian Society,

This is the Official Meeting Notice for the 2024 Annual Meeting of the membership of Michael Servetus Unitarian Society to be held on **Tuesday, May 14, 2024 at 7pm.**

Please arrive at **6:45 p.m**. so that we can take attendance and confirm a quorum (we're asking for 40% of membership because of holding a vote to adopt a new name). The Call to Order will occur at 7:00 PM or when quorum is reached, whichever is later.

The annual meeting is an opportunity for the congregation to hear highlights and accomplishments of the past year and to conduct church business. The meeting agenda includes:

- Annual reports from the minister and board
- Elections for the Board of Trustees and the Leadership Development Committee
- Adoption of the 2024-25 proposed budget
- Important Announcements from the UUA

These two special votes will be taken:

- Vote to adopt the proposed new name: *Merging Waters Unitarian Universalist Congregation*. If the motion passes, this vote authorizes amending the Articles of Incorporation and the Bylaws with the new name.
- Vote for a Bylaws change to allow the Leadership Development committee to vary from 3-5 members rather than set a fixed number.

Per the Bylaws, the candidates nominated to fill expiring terms or vacancies on the Board of Trustees and candidates for the Leadership Development Committee must be submitted to the membership with this meeting notice.
